SportsCity Facility Rules and Regulations

The following terms and conditions for your group booking a rental at SportsCity. Participants and/or spectators must abide by the facility's rules and regulations or they may be removed from the facility and NO refund will be given.

Alcoholic Beverages / Tobacco Products: Cereal malt or alcoholic beverages and tobacco products are prohibited in the athletic areas of the facility at all times. Smoking is not allowed anywhere inside the facility. Violators are subject to immediate removal and no refund will be given.

Restrictions: Bicycles, roller blades, Heelys, skate boards, martial arts weapons, any other form of weapon, fencing, archery, or sparing equipment, or anything that could be deemed a weapon, are NOT allowed in the facility unless supplied by SportsCity.

PA / DJ Equipment: If rented, a SportsCity employee will train someone in our group on how to run / use the PA / DJ Equipment and we will be responsible for running the PA / DJ Equipment. I understand that I must supply a valid credit card number and that any damage done to any of the equipment, I will be held accountable for, my credit card will be charged, and SportsCity will send me a receipt for the repairs.

NO PETS ALLOWED!

1. For normal rentals a non-refundable, non-transferable deposit of 1/3 the total amount due, unless otherwise arranged, must be made at the time your rental is booked. Lock-ins require a \$300.00 non-refundable deposit. Field trips require a \$100.00 non-refundable deposit. All deposits will be deducted from the total due.
2. Your remaining balance, unless otherwise arranged, must be paid in full the day of and prior to the event being set up.
3. If your group is Tax Exempt you must provide SportsCity a copy of the exemption letter.
4. You will need to have a \$1,000,000.00 "Certificate of Liability" policy and provide a copy to SportsCity or.....
5. If not available each participant must complete a SportsCity waiver. Those under that age of 18 yrs must have a parent or legal guardian sign. For convenience you can print this waiver from our website www.sportscitykc.com, fill in your groups name and date of event, and then photo copy as needed.
6. A \$250.00 Trash / Clean-up deposit (if required) must be paid at least two (2) weeks in advance. For ease, please issue a separate check as this deposit may be refunded if the facility is left in the same condition as it was found. If refunded, your original check will be returned to you.
7. You are responsible for providing adequate supervision for your rental. Depending on the size of your group, SportsCity recommends having between 10 to 20 adult chaperones.
8. NO outside food or drink is allowed unless a "Step Aside" package (\$2.00 per person) is purchased.
9. Food and drink are NOT allowed on the fields, court or in batting cages / tunnels.
10. NO glass containers or bottles of any kind are allowed in the facility other than inside the Post Game Bar & Grill area.
11. There is to be NO smoking inside the building.
12. There is to be NO gum, sunflower seeds, drinks, or spitting on the fields.
13. NO metal cleats allowed on fields.
14. NO cleats of any type are allowed on the basketball court.
15. SportsCity must approve all decorations, signs, banners, and / or posters in advance.
16. There will be NO dunking or hanging from the rims / netting on the basketball court.
17. There is to be no climbing or hanging from any of the netting on / around the soccer / football fields.
18. Batting helmets are to be worn in the batting cages and there is to be only one (1) person at a time in each batting cage.
19. SportsCity will not be responsible for lost, stolen or damaged items either inside or outside the facility.
20. SportsCity office telephones are reserved for SportsCity business and may only be used for emergencies.
21. All offices or storage rooms are off limits unless given permission to enter or use.
22. You will be held accountable / liable for all damages and all actions of your participants and spectators.
