SIGN-UPS: Players may register as a team or individually to be placed on a team by SportsCity. Can request to play with friends. Be sure to note friends name on your form.

TEAMS: Can be all Boys, all Girls, or Co-ed. Average 8-10 players per team. Teams formed by SportsCity will normally be co-ed teams. Teams will be formed as equally as possible with boys/girls and mixture of ages.

PRACTICE: A one (1) hour "Meet the Team / Practice" on the 1st Saturday of each session. Each week thereafter will consist of a 30 minute practice prior to the start of each game. Games last one (1) hour or three (3) innings, whichever comes first.

SCHEDULES: Will be issued at the Meet the Team practice. Team shirts should also be available that day.

GAME TIMES: Depends on the number of teams. Normally 9:00am start. Example: if your start time is 9:00am you will practice from 9:00-9:30 then start your game. Next set of games will follow the same procedure.

PICTURES: We have a company that will take team and individual photos on the dates we have set up. Though it is not mandatory you have individual photos taken, we do ask that everyone shows for the team photo.

RELEASE and WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY and PARENTAL CONSENT AGREEMENT

IN CONSIDERATION of being permitted to participate in any way in the **SportsCity Activity**, I, for myself for personal representatives, assigns, heirs, and next of kin:

- ACKNOWLEDGE**, agree, and represent that I understand the nature of SportsCity Activities and that my child is qualified, in good health, and in proper physical condition to participate in such Activity. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue my child from any further participation in the Activity.
- FULLY UNDERSTAND THAT: (A) SPORTSCITY ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS"); (B)** These risks and dangers may be caused by my child's own actions or inactions, the actions or inactions of others participating in the activity, the condition in which the activity takes place, or the negligence of the releasees named below; **(C)** There may be **OTHER RISK AND SOCIAL AND ECONOMIC LOSSES** either not known to me or not readily foreseeable at this time; and **I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES** I incur as a result of my participation or that of the minor in the Activity.
- HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE SPORTSCITY**, their respective administrators, directors, agents, officers, members, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owner and lessors of premises on which the Activity takes place (each considered one of the **"RELEASEES"** herein), **FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS AND I FURTHER AGREE** that if, despite the RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I, or anyone on my behalf, makes a claim against any of the Releasees. I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT INDUCEMENT OF ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PROTION OF THIS AGREEMENT IS HELD TO BE INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.

RELEASE FOR MINOR (under 18) PARTICIPANT'S

AND I, THE MINOR'S PARENT AND/OR LEGAL GUARDIAN, UNDERSTAND THE NATURE OF SPORTSCITY ACTIVITIES AND THE MINOR'S EXPERIENCE AND CAPABILITIES AND BELIEVE THE MINOR TO BE QUALIFIED, IN GOOD HEALTH, AND IN PROPER PHYSICAL CONDITION TO PARTICIPATE IN SUCH ACTIVITY.
