## RELEASE and WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY and PARENTAL CONSENT AGREEMENT

**IN CONSIDERATION** of being permitted to participate in any way in the **SportsCity Activity**, I, for myself for personal representatives, assigns, heirs, and next of kin:

1. **ACKNOWLEDGE**, agree, and represent that I understand the nature of SportsCity Activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.
