Lock-In Rules & Regulations

The following terms and conditions for Organizations / Individuals hosting a Grad Night or Lock-In at SportsCity. Organizations / Individuals and their participants must abide by the facility's rules and regulations or they may be removed from the facility and **NO** refund will be given.

Alcoholic Beverages / Tobacco Products: Cereal malt and alcoholic beverages, smoking and tobacco products are prohibited in the athletic areas of the facility at all times. Violators are subject to immediate removal and no refund will be given.

Restrictions: Bicycles, roller blades, skate boards, baseballs, softballs, martial arts weapons, any other form of weapon, fencing, archery, sparing equipment, and pets are **NOT** allowed in the facility unless supplied by SportsCity.

PA / DJ Equipment: If rented, a SportsCity employee will train someone in our group on how to run / use the PA / DJ Equipment and we will be responsible for running the PA / DJ Equipment. I understand that I must supply a valid credit card number and that any damage done to any of the equipment, I will be held accountable for, my credit card will be charged, and SportsCity will send me a receipt for the repairs.

1. A non-refundable \$1,000.00 deposit must be made at the time your reservation is booked.
2. A \$250.00 Trash / Clean Up deposit must be paid at least two (2) weeks in advance. This deposit may be refunded if the facility is clean when your group leaves.
3. The remaining balance for the event must be paid in full on the day of the event, prior to the event being set-up.
4. The Organization / Individual having the event must provide adequate supervision for the event. Depending on the size of your group, SportsCity recommends having between 10 to 20 adult chaperones.
5. It is the responsibility of the Organization / Individual to ensure that each participant has completed and signed a SportsCity Liability Waiver and that parents of those participants under the age of 18 have signed the waiver prior to any participation at SportsCity.
6. Food and drink are restricted to the Post Game Bar & Grill and Concession areas only. **NO** outside food or drink is allowed unless a "Step Aside" package is purchased.
7. **NO** glass containers or bottles of any kind are allowed in the facility other than inside the Post Game Bar & Grill area.
8. There is to be **NO** smoking unless inside the Post Game Bar & Grill area.
9. There is to be **NO** gum, sunflower seeds, drinks, or spitting on the fields.
10. SportsCity must approve all decorations, signs, banners, and / or posters in advance.
11. The facility must be left in the same condition as it was found. See item #2.
12. There will be **NO** dunking or hanging from the rims on the basketball court.
13. SportsCity will not be responsible for lost, stolen or damaged items either inside or outside the facility.
14. SportsCity office telephones are reserved for SportsCity business use only and may not be used as a reference number for participants for the event and may only be used by participants in the event of an emergency.
15. The contact for the event is responsible for all damages and all actions of their guest.
